SeedStart Gaia is a soluble-liquid nutrient formulation of nutrients that promote the rapid uptake, absorption, and movement of nutrients. SeedStart Gaia is designed for use as a seed, foliar, or in-furrow applied product. It is intended for use on all grain, row, vegetable, and grass crops. Can be applied in combination with fungicides and pesticides. When combining with other products, a standard jar test is always recommended. Use only as directed.

Totes and drums should be mixed prior to use and at least every 3 months during storage by recirculating pumps or by pulse-air systems that introduce bursts of compressed air. For smaller packages, shake before use.

CROP TYPE

Grain and Row Crops — Cereals, corn, canola, legumes/pulse (dry beans, peas, lentils, garbanzos, alfalfa, soybeans), large and small seeded vegetables, grass seed.

Seed Treatment: 0.5 – 2.0 oz./cwt.

In-Furrow: 2.0 – 8.0 oz./acre

Foliar: 2.0 – 8.0 oz./acre
